Service Conditions to **Worldwide PB**



Licensed Hanoverian Stallion

Artificial Insemination

Fees and conditions:

- Service fee of AUD\$2,200 which includes Goods and Services Tax (GST) and a AUD\$330 non-refundable booking fee
- All fees are payable in **advance** of semen shipments
- Should Worldwide PB be injured in any way to prevent future breeding, suffer fatal injury or be sold before shipment of semen, the mare owner will be entitled to a refund (excluding the booking fee)

Life Foal Guarantee (LFG) - for mares within Australia

LFG conditions:

- A booking fee will apply (AUD\$330, includes GST)
- Stallion must be alive and in serving condition
- Mare must be alive
- Does not apply to frozen semen inseminations

LFG applies only if the mare:

- Fails to conceive, or
- Aborts the foetus, or
- Foal dies within 24 hours of birth

LFG is void if:

- Loss of pregnancy due to owners' neglect
- Owner fails to have a veterinary examinations
 - o for twins or abortion at or before 18 days after insemination and
 - o between 40 and 60 days after conception and provide veterinary certificates

NOTE:

- Tennyson Training Stables and Stud (TTSS) must be notified within 7 days of the results of the pregnancy tests or the LFG will be void!
- TTSS reserves the right, without explanation, to refuse service to a mare
- Service Certificate will not be issued without proof of identity or appropriate registration papers of the mare
- Owners are advised to be aware of the risks involved in breeding horses, please seek advice from your veterinarian
